OVERVIEW

Attempts will be made to keep every vendor site unique. A check for \$200.00/\$300.00 for food / beverage vendors and \$100.00 for non-food is required with all vendor applications. Vendors provide their own assistance, tents, tables, chairs, lights, and generators if needed. Food Vendors are required to maintain at least one garbage can (Provided) at their booth. Vendors selling food must obtain a Health Department Mobile Food Permit. A copy of the permit must be displayed at your booth and easily visible.

Applications do not confirm acceptance into the event. Confirmation will be made via email or telephone call with receipt to follow via mail / email. Vendors will be chosen and contacted by **May 1st , 2022 or earlier depending on time of application sent.**

Deadline for applications is **May 16th, 2022.**

Failure to pay in full prior to the event nullifies application. Checks must be made payable to **The Rockingham Company, LLC.** An application is considered a commitment to the festival.

SET-UP

Vendors are responsible for a timely arrival.

Set up is between Thursday, May 18th from 11 AM - 8 PM and Friday, may 19th from 8 AM - 11 AM

Space is forfeited (and monies not returned) if not occupied by 12:00 PM on May 19th, 2023 Vendors are responsible for cleaning and restoring their area to this original appearance by 11:00 AM, May 21st, unless other arrangements are made with us. No vehicle movement after 12:00 PM on Saturday, May 21st, 2022 or during the show.

A separate vendor parking area will be used for the festival.

INSURANCE


FOOD Vendors are responsible for their own insurance. Please provide a copy of your insurance along with your application.

TENTS

Vendors must supply their own tents.

Vendors should have adequate protection for weather; sun, heat, cold, rain, or wind.

No guide wire or rope shall cross any means of public egress.

Tent stakes shall be railed off, capped, or covered so as not to prevent a hazard to the public. Tents MUST be weighted down.

Recommended tents for non-food vendors are 10'x10'. FOOD VENDORS need to have fire resistant tent canopy.

FIRE SAFETY

Each food vendor is required to have a fire extinguisher.

A class "K" fire extinguisher is required for any cooking operation involving a deep fat fryer. All extinguishers shall have a tag attached indicating that they have had a current annual inspection.

Vendors are responsible for the fire extinguisher cost.

VENDOR PARKING

All vendors will be provided assigned parking onsite at the festival event location, after tents, merchandise, and all products are unloaded to booth location. A parking pass will be provided and must be displayed on your dashboard during the event.

DUPLICATION

We appreciate that you work hard, and we want you to be successful. In light of that, we will do our best not to duplicate vending products or services.

ACCOMMODATIONS

This is a 1-Day event. Should you choose to stay overnight, you are welcome to camp at no cost.

Please let us know if you decide to camp. We have camping available behind each vendor's

space. Please note in the "Additional Special Needs" if you wish to camp behind your space. - - - -
